	Being Reviewed for grades 6-8	 Top level overview of secondary materials that teachers have been reviewing. No recommendation from the teacher committee at this time. *Five different curriculums being looked at. There is a chart for each in the presentation. TEKS for health changes go in effect next school year (2022-2023). There are things that are required to be taught that have not been required to be taught before. Opt-in form for parents. Students for whom form not completed would be pulled and given an alternate assignment. Meeting guests can e-mail YL for a copy of the TEKS. Members should have a copy in their folders. Some printed teacher additions available & passed around. Available to be viewed at Central Office. Reach out to Mrs. Barry to schedule a time. *McGraw Hill, *Esteem, *GoodHeart Wilcox -Member question: If a parent opts-in, are they opting in for all seven or can they opt-in for say 1,5,&6?
